Purpose of this document

'you' includes individual guarantors and any person who holds office in an entity which is a guarantor.

'we' means MyState Bank Limited and its agents.

'Group' means MyState Bank limited and its subsidiaries

'your information' means information about you or your entity (such as name and contact details), your interactions with MyState Bank and your credit history (such as amount borrowed, repayment history and information received from credit reporting bodies). It may include publicly available data about you.

Acknowledgement and Consent

What you need to know

1. Why we collect your information and what we use it for:

We collect your information to assess whether to accept you as a guarantor; to identify you, and to administer our customer relationships, and for internal processes including risk management.

2. Exchanging information with credit reporting bodies;

We exchange your information with credit reporting bodies and third parties providing fraud detecting services in order for us or them to:

- decide whether to accept you/your entity's offer to act as guarantor; and
- manage credit guaranteed by you/your entity and collect overdue payments.

If you don't meet your payment obligations, we may disclose this to a credit reporting body.

Please note: You have the right to access any credit related information from us, to request us to correct the information, and to make a complaint to us in relation to the information.

3. Other people we may exchange your information with:

You authorise us to exchange your information with members of the Group who may use your information for any of the purposes we can.

We may exchange your information with others outside of the Group.
